2 3 THE STATE OF OREGON C# 21-CR-61225 DA# 2441395-2 4 Crime Report PP 21-681328 5 Plaintiff, MOTION FOR PRELIMINARY 6 VIOLENT FELONY **DETERMINATION (JC 3)** 7 TUSITALA JOHN TOESE 8 Defendant(s). 9 The charging document in this matter contains offenses that the State alleges are violent felonies, specifically: Count 1 - Assault in the Second Degree (ORS 163.175(b)); Count 2 - Assault in the Third 10 Degree (ORS 163.165); Count 3 – Assault in the Second Degree (ORS 163.175(b)); Count 4 – Assault in the Second Degree (ORS 163.175(b)); Count 5 – Assault in the Third Degree (ORS 163.165); Count 11 6 – Unlawful Use of a Weapon (ORS 166.220); Count 7 – Unlawful Use of a Weapon (ORS 166.220), 12 because: 13 it appears in the December 15, 2021 Presiding Judge Order, "RE PREVENTATIVE DETENTION HEARING PROCEDURES AND SECURITY RELEASE IN VIOLENT 14 FELONIES," list of offenses categorically subject to ORS 135.240(4); or 15 the underlying allegations set forth in the attached affidavit indicate it is "a felony offense in which there was an actual or threatened serious physical injury to the victim." ORS 135.240(6). 16 17 If the court finds, either from the face of the information or the attached affidavit, that an offense in this charging document is a violent felony subject to ORS 135.240(4), the defendant is not statutorily 18 eligible for security, conditional, or recognizance release pending a detention hearing before the court. 19 The State does not stipulate to the setting of security in this matter and requests that, pursuant to ORS 135,240(4) and the implementing PJO referenced above, the court defer a determination of whether 20 to set a security amount pending a preventative detention hearing. Absent waiver by the defendant, this hearing must occur within five calendar days. ORS 135.240(4)(b).
