2) That the said defendant has not complied with the said release conditions in the following particulars, to wit:

On 12/09/17, Mr. Toese was released third party to PRS. Per his signed release paperwork, Mr. Toese was ordered to report in person to PRS on 12/11/17 after court. On this same date, Mr. Toese was advised of his conditions of release which include but not limited to:

Report by phone every Monday

- Mr. Toese failed to make the following phone check ins: 01/15/18, 01/22/18, 01/29/18 and 02/05/18
- On 12/12/17, I called Mr. Toese to introduce myself as his PRS Case Manager since I was not available when he reported in for his intake on 12/11/17. He stated that he would not talk to me, not abide by my directives since I was calling from a blocked number.
- On 12/12/17, I sent an email to Mr. Toese to provide my contact information to prove who I
 work for since he refused to talk to me over the phone.
- On 01/30/18 I called and spoke with Mr. Toese to ask why he stopped phone reporting and/or not respond to my email. Mr. Toese began to yelling and stated he refused to talk to me since I was calling from a blocked number. He continued yelling by saying he was never told he had to phone report weekly, that he was never told of a court date. I explained that he was informed and that he signed his conditions stating he was informed. The call was suddenly terminated.
- On 02/01/18, I called Mr. Toese again; this time from my work cell phone to see if he would be willing to talk to me. Mr. Toese answered and stated he was never reminded that he had to continue to phone check in weekly. I explained that his signed conditions states otherwise. I informed Mr. Toese that he could not miss another check in and if he did, he could get revoked. He missed his 02/05/18 check in.

It should be noted that Mr. Toese has one other PRS case (#17CR55661) which a revocation will also be asked for, for the same reasons listed above. It does not appear that Mr. Toese is willing to comply with the conditions of release, therefore I ask that it be revoked.
